Trade-in, Buy or Consignment Policy

Your detector must be in <u>Mint to Excellent Condition</u> for us to consider buying it outright. If we are listing it on consignment basis, it must be in Very Good condition or better for trade-in. Please do not send us out of date, damaged or rough condition detectors. It is your responsibility to clean your detector before shipment. Any detectors sent to us covered with mud, tape, or unsightly residue will be subject to a \$25.00 cleaning fee. Remember, the better your detector looks, the better it sells... and the more it will bring.

Guidelines:

- Your detector <u>must</u> be in perfect working condition; no exceptions (unless you want us to send it to the factory and invoice you for shipping and any repairs not covered under warranty).
- Be sure to fill out the application form on page 2 and send it along with your detector.
- You will need to contact us before shipping the detector.
- In the event your detector needs to be repaired you will need to provide us your Credit Card information (you may call or email the card information).
- If your detector requires repair work we will contact you with the factory repair price and time schedule quote. All repair work will be preformed by the manufacturer of the detector and will be subject to the manufacturer's warranty.
- These policies help protect our customers whether selling or purchasing used detector through us. It also helps us to maintain our reputation for quality products and service.
- SERVICE FEES: We charge a service fee based upon the final sale price of your detector. The rate is 10% when applying the proceeds to the purchase of a new detector from us. The rate is 20% when we issue you a check after the sale of your detector and payment for it has cleared bank processing. If you have any questions about our service fees, contact us prior to shipping your detector to us.
- These rules apply to trade-in, buying, or consignment listing of your detector. If you change your mind; or want your detector shipped back, you are responsible for paying the return shipping costs before return shipment is made.
